Plumb Heart Center Provides the Best in Pediatric Care for Young Heart Patients Like Carter

Imagine seeing your two-week old son struggle to breathe. And then tests reveal a congenital heart defect (CHD), specifically an atrioventricular (AV) canal defect with two holes in his heart and leaky valves. It was a concerning time for baby Carter, his mom Hayley and the rest of their family. Carter began care with Mercy Pediatric Cardiology Clinic with Mark Zittergruen, MD, FAAP, FACC, MBA.

After an exhausting and frightening series of infections and multiple hospital stays, Carter was finally well enough to undergo successful heart surgery at UI Stead Family Children's Hospital on June 1, 2017. He was nine months old.

We recently followed up with Hayley to check on Carter's progress. Currently, Carter is a very active fiveyear-old that participates in wrestling, soccer, football, swimming and T-ball. He has had a few sicknesses as he's grown up, but ultimately, his health has improved.



In addition to visiting his pediatrician, Carter sees Dr. Zittergruen yearly for an echocardiogram and check up.

"We couldn't have asked for a better

doctor to get us through everything Carter has been through," Hayley said.

"Dr. Zittergruen and his nurses are always there to answer any questions we have. They are very attentive and stay in touch."

Carter has one older sibling and recently found out he's going to be a big brother in November! Though Hayley and her husband Eric have no family history of heart conditions, they chose to have an echocardiogram done on their baby daughter. Given Carter's condition, they wanted to be prepared.



The construction project is progressing on schedule and workers will connect the Plumb Heart Center to the main hospital by building a skywalk across 8th Avenue SE this month. Roofing. sidewalks and window installation will continue throughout October.

Virgil served in the Army Reserves for four years after graduating high school in 1961. He never married, instead choosing to focus on the family sawmill business alongside his brother Jerry. The two men shared a home together in Chelsea, Iowa and were highly regarded for their strong work ethic.

Virgil was extremely well-read and knowledgeable on a wide range of subjects. While he never went to college, he valued education, so much so that he created a college scholarship opportunity for high school seniors from his home community.

In 2013, Virgil lost his brother to prostate cancer. Jerry spent his final days at the Dennis & Donna Oldorf Hospice House of Mercy. That experience with hospice touched Virgil in a significant way and moved him to create an enduring legacy. Virgil chose to leave one quarter of his estate, a gift of more than

The Mercy Touch[®] Inspires Grateful Patient Gift

When expectant parents Hannah and Aaron Brewer first toured Mercy's Birthplace, they knew their daughter, Maribel, would probably need to spend some time in the Neonatal Intensive Care Unit (NICU) following her birth. However, they didn't expect her to be there for nearly two months.



"She was born at 29 weeks, six days," Hannah said. "We knew she would have to come early due to complications, but we were thinking four to six weeks early – not 10."



Deb Spina, was so grateful for the care her daughter and granddaughter received that she made the decision to support the Mercy Foundation through a Grateful Patient gift. Once it was determined that baby Maribel needed to come, Hannah knew they were both in good hands.

"I'll never forget laying in the bed and it was like this choreographed ballet," Hannah said. "People who needed to help me knew what they were doing. Nurses and doctors who needed to be ready for Maribel [knew what they were doing]. It was just amazing."

At Mercy, 100% of the Birthplace suites are equipped with NICU

technology – one of only a few NICUs of its kind in the country. Consequently, while Maribel received the care she needed for 55 days, mom and dad were also able to stay together with her in the room at Mercy. During that time, Hannah and Aaron said the staff at Mercy became like family: **"To the point where it was almost bittersweet to leave,"** Hannah said.

Hannah's mother, Deb Spina, was so grateful for the care her daughter and granddaughter received that she made the decision to support the Mercy Foundation through a Grateful Patient gift. "I was absolutely stunned, so appreciative and so very grateful when I learned about the NICU in mom's room," Deb said. "The attention and the care were 24/7, around the clock. Any questions were answered, all procedures were explained. Anything that needed to be done for Maribel, all the equipment was brought in so that Hannah and Aaron could watch and be here."

Today, Maribel is happy, healthy and thriving.

"When she was born, she was only 3 pounds, 2 ounces," Hannah said. "She had the scrawniest little legs and no butt, and now she has nice, chunky little legs and little sweet cheeks."

"There are no developmental delays," added Deb. "It is just an absolute miracle. We were so blessed to have this crew taking care of them."

Hannah and Aaron continue to be grateful for *The Mercy Touch*[®] and donor support providing state of the art neonatal care at Mercy.

"Every time I get to snuggle her, kiss her, make her smile, clean up her spit-up, change her diaper, watch her check off another milestone, I think to myself, this is because of *The Mercy Touch*," Hannah said.

"Because, without the love, compassion and expertise, she wouldn't be here. And, sometimes, I wonder if I would be here. And so, *The Mercy Touch* is just something I will forever be grateful for." ♥
